The number of dial-in users may be initially restricted to 5 (Five) for all the above packages. For more than five dial in users, additional 5% of the account charges in 250, 500 and 1000 hours packages may be charged for every additional 5 (Five) users or part thereof .

15. Important instructions for filling up of the form:-

- i) The form may be filled up in Capital letter only
- ii) In the absence of PAN/GIR number, declaration in form 60/61 may be furnished in the enclosed proforma.
- iii) In case of sole proprietary concern, proprietor may sign himself and affix rubber stamp.
- iv) In case of partnership concern all partners or any one of the partners duly authorized or Person with the Power of Attorney may sign. In case of company, signature should be of a person on behalf of a Company in accordance with the provisions of its Articles of Association. In case of Partnership concerns, copy of (i) power of Attorney for authorization & (ii) Partnership Deed, and incase of Limited Company, a copy of the Articles of Association may be attached.
- v) In case of Government Department, Authorized person may sign and affix rubber stamp.
